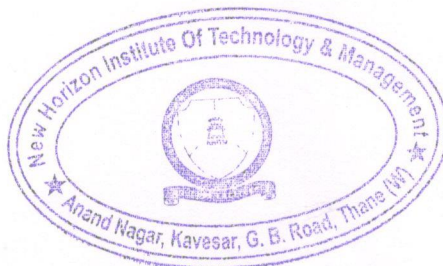

The student can apply for the following scheme as per their Parents / Guardian annual income: -

- **(Social Justice and Special Assistance Department) SC category** students having their Parents/Guardian annual income less than or equal to Rs. 2,50,000 shall apply for the **Government of India Post-Matric Scholarship.**
- **(Social Justice and Special Assistance Department) SC category** students having their Parents / Guardian annual income above Rs. 2,50,000 to unlimited shall apply for the **Post-Matric Tuition Fee and Examination Fee (Freeship).**
- **(Tribal Development Department) ST category** students with their Parents/Guardian annual income less than or equal to Rs. 2,50,000 shall apply for the **Government of India Post-Matric Scholarship.**
- **(Tribal Development Department) ST category** students with their Parents / Guardian annual income above Rs. 2,50,000 to unlimited shall apply for the **Post-Matric Tuition Fee and Examination Fee (Freeship).**
- **(VJ-NT, OBC and SBC Welfare Department) VJ-NT, OBC and SBC Category** students having their Parents/Guardian annual income less than or equal to Rs. 1,00,000 shall apply for the **Government of India Post-Matric Scholarship.**
- **(VJ-NT, OBC and SBC Welfare Department) VJ-NT, OBC and SBC Category** students having their Parents/Guardian annual income less than or equal to Rs. 8,00,000 shall apply for the **Post-Matric Tuition Fee and Examination Fee (Freeship).**
- **(Department of Technical Education) Rajarshi Chhatrapati Shahu Maharaj Shikshan Shulkh Shishyavrutti Yojna EBC and SEBC** The Total Annual Income of Family / Guardian should not be more than 8 Lakhs for availing EBC concession.
